

Soil and Water Conservation District Board Meeting June 2021 NRCS District Conservationist Report

• We are working on hiring 2 additional Soil Conservationists in Redwood Falls.

EQIP

- No changes in EQIP preapprovals for all 3 counties. Minnesota did request \$4 million more in EQIP funds.
- The Redwood Falls Team is one of 3 Minnesota teams that was selected for the Climate Smart Ag EQIP pilot program. There is \$1 million available for Minnesota. Sign-up is limited to only select practices (Conservation Cover, Residue Management, Cover Crop, Grassed Waterways, and Nutrient Management are some of the most common ones we will be looking at in our team). Sign-up deadline is July 9 but applications already on file for the practices can just be rolled into this sign-up.
- Brown County received 1 MAWQCP RCPP application.
- Redwood County received 9 MAWQCP RCPP applications.
- Renville County received 2 MAWQCP RCPP applications.
- Brown, Redwood and Renville County currently have 49 active EQIP contracts.

CSP

- We are working on getting contracts developed and signed for the 5 preapproved CSP applications in Redwood and Renville County.
- Brown, Redwood and Renville County currently have 78 active CSP contracts.

CRP

• CRP is now open for sign-ups. General sign-up deadline is July 23, 2021. Continuous sign-up deadline is August 6, 2021.
