

## **RENVILLE COUNTY SOIL AND WATER CONSERVATION DISTRICT PRIVACY POLICY/DISCLAIMER AND SMS TERMS**

After you send the SMS message "STOP" to us, the SWCD will send you an SMS message to confirm that you have been unsubscribed from the text messaging service. After unsubscribing, you will not receive further SMS messages through this service unless you wish to start the service back up. To start receiving SMS messages again, you may send the SMS message "START" to the short code. Users having issues with SMS text messaging can reply with the keyword "HELP" for more assistance.

The SWCD is not liable for delayed or undelivered SMS messages.

When using the SWCD's SMS service, message and data rates may apply for any SMS messages sent to you from the SWCD or to the SWCD from you. If you have any questions about your text or data plan, you are encouraged to contact your wireless provider.
